## Sir/Madam,

I am directed to invite your attention to Para 5.3 of the Deployment of Contractual Persons Policy, 2022 as amended from time to time vide which it has been provided that all Indenting Organisations shall submit their for requisitions for contractual manpower to HKRN with the copy of prior approval of Finance Department indicating the quantity of manpower required for any of the notified job roles, location (district), the period for which required, along with details of the available budget for payment of wages through the designated Nigam web-portal.

- 2. Requests have been received from various Departments/Organizations to renew the contract of manpower already deployed through HKRN. The matter has been considered and decided as follows:
  - Extension of contractual engagement of existing deployees of HKRN to various Departments/Organizations is allowed till 31.03.2025 only.
  - ii) For further extension of services beyond 31.03.2025, the Indenting Departments/Organizations shall proceed as follows:
    - a. In case of deployment against regular sanctioned posts, the indenting entity shall provide proof of placement of indent to recruiting bodies (HSSC etc) and also provide fresh approval of Finance Department for extension of contracts.
    - b. In case of deployment against contractual sanctioned posts, the indenting entity shall provide fresh approval of Finance Department for extension of contracts.
